THE CALL DOCUMENTATION

I. THE RUSSIAN FELLOWSHIP PROGRAMME TO EMMRI within Horizon 2020 CREMLINplus project offers fellowships to scientists in management positions from Russian Research Infrastructures to study for "Executive Master in Management of Research Infrastructures" (EMMRI) Master degree at the University of Milano-Bicocca in Milan, Italy.

Fellowships are available on a competitive basis and cover full tuition fee, accommodation, living expenses and flights to and from Milan for up to 7 on-campus visits in Milan (3 days each) and the final Graduation exam.

Reimbursement of travel and accommodation expenses is made according to the rules and travel policy of the University of Milano-Bicocca.

II. THE EMMRI PROGRAMME (OVERVIEW)

The EMMRI programme (Executive Masters in Management of Research Infrastructures) was developed within RItrain (http://ritrain.eu/), an EU-funded Horizon 2020 project aimed at improving and professionalizing training for research infrastructure managers and leaders.

The programme is delivered by the University of Milano-Bicocca (https://emmri.unimib.it)

The idea of the programme is to train the new generation of executives of national and international research infrastructures, equipping them with state-of-the-art high level managerial and leadership skills, tailored to academic and scientific needs, and also to the needs of scientific service providers.

This Master programme is an official MBA under the Bologna rules. It is organized in 12 modules, among which 5 full online and 7 blended - on-campus (3 day visits to Milan) and online. The modules combine lectures, talks by experts from EU Research Infrastructures and guest speakers, webinars and case study analysis. Towards the second half of the curriculum the participants will develop and implement a supervised field project – thereby implementing learnings into practice.

The total duration of the Masters is 18 months.

III. ELIGIBILITY CRITERIA

Candidates to the Russian Fellowship Programme to EMMRI must meet the following criteria:

- 1. be citizen of the Russian Federation or a long-term resident of Russia.
- 2. be a first-level or second-level managers of the Russian Research Infrastructures (e.g., Director Generals, Chief Operating Officers or their equivalent, recently appointed or upcoming senior managers, Heads of National Nodes, Head of Department, Heads of Finance and Administration, HR and Communication, middle management and programme managers, Head of labs and other scientists holding/moving to managerial positions in RIs);
- 3. have a University degree and experience of 7 years work in Russian Research Infrastructures;
- No age restrictions apply.
 Female participation is strongly supported.
- 5. Very good level of written and spoken English (approved by certificates or experience)

The CREMLINplus WP9 experts screen and carry out a preliminary check of applications and the supporting documents in line with the CREMLINplus Fellowship programme' eligibility criteria and prepare **the LIST of candidates** for the Ministry of Science and Higher Education of the Russian Federation.

- **4. Acknowledgement of the LIST of candidates by the** Ministry of Science and Higher Education of the Russian Federation
- 5. Notification of all candidates on screening results (After acknowledgement of the List of candidates by the Ministry)

NUST MISIS informs all candidates on the screening results by e-mail and invites candidates from the LIST approved by Ministry to apply to EMMRI programme through the website of the UNIMIB (https://emmri.unimib.it)

STAGE 2. FINAL SELECTION OF RUSSIAN CANDIDATES TO EMMRI, MANAGED BY THE UNIMIB

1. Submission of applications to EMMRI programme

2. Evaluation and final selection by UNIMIB

The UNIMIB evaluation committee evaluates applications of all candidates (including Russian candidates) in line with EMMRI criteria and identify the final list of participants.

The selection will be done on the basis of UNIMIB published application process (https://emmri.unimib.it/admission/).

3. Notification of successful Russian candidates on evaluation and selection results

The result of the selection will be communicated soon to the candidate after the application is evaluated. UNIMIB informs successful Russian candidates on results of final evaluation by e-mail.

4. After the admission, candidates will be required to officially register at the University of Milano-Bicocca following the specific requirements for Masters programmes.
